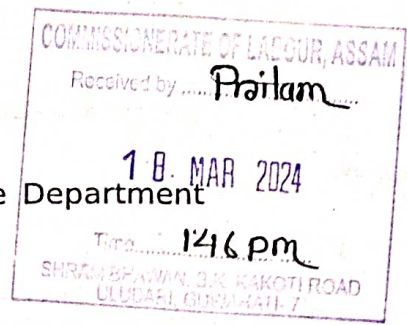

Dated Dispur, the 14th January, 2024

No.E-273060/491 : In continuation to the Notification No. E-273060/476, dtd. 27th April, 2023, the rates of VDA payable to the workers engaged in loading and unloading of urea bags in the State of Assam are fixed in the basis of 75% rise on average all India General CPI for Industrial Workers.

And whereas the All India General CPI (Base 2016=100) average for the period July, 2022 to December, 2022 has risen by 2.56 points (i.e, 75% of rise 1.46) in the average CPI points of the period January, 2023 to June, 2023.

Now, it is hereby notified that the following VDA shall be payable to the workers engaged in loading & unloading of urea bags in the State of Assam w.e.f. 01-07-2023.
