NOTIFICATION

In pursuance of Notification No. ACL/43/2004/3542 dtd. 17th March, 2021, the rate of VDA to be paid to workman employed by and through contractors as mentioned below in respect of cases which are not covered under Minimum Wages Act, 1984 and where the workman employed by the contractors do not perform the same or similar nature of work as done by workers, directly employed by the Principal Employers of the establishment. The following rates are fixed on the 100% rise on average all India Consumer Price Index (base 2001=100) from the period July, 2020 (CPI Points 336) to December, 2020 (CPI Points 342).

In pursuance of Notification No. ACL/43/2004/9383 dtd. 12th Nov., 2021, the rate of VDA to be paid to workman employed by and through contractors as mentioned below in respect of cases which are not covered under Minimum Wages Act, 1984 and where the workman employed by the contractors do not perform the same or similar nature of work as done by workers, directly employed by the Principal Employers of the establishment. The following rates are fixed on the 100% rise on average all India Consumer Price Index (base 2001=100) from the period January, 2021 (CPI Points 340.416) to June, 2021 (CPI Points 350.496).


