NO.GLR(RC)62/2018/12 : The following draft of certain rules further to amend the Assam Plantations Labour Rules, 1956, hereinafter referred to as the Principal Rules, which the Governor of Assam proposes to make in exercise of the powers conferred by section 43 of the Plantations Labour Act, 1951 (Central Act No. 69 of 1951) is hereby published as required under sub-section (1) of section 43 of the said Act, for the information of all persons likely to be affected thereby and notice is hereby given that the said draft rules shall be taken into consideration after the expiry of a period of 60 (sixty) days from the date of publication of this notification in the Official Gazette.

Any objections and suggestions, which may be received from any individual or organisations with respect to the said draft rules before the expiry of the period specified above shall be considered by the Governor of Assam.

Objections or suggestions, if any, may be sent to the Secretary to the Government of Assam, Labour Welfare Department, Janata Bhawan, Dispur, Guwahati- 6.

Short title and commencement	1.	(1)	Theses rules may be called the Assam Plantations Labour (Amendment) Rules, 2019.
		(2)	They shall come into force on the date of their publication in the Official Gazette.
Amendment of rule 3	2.		In the principal Rules, in rule 3, -
		(i)	in clause (v), the word "and" appearing after the punctuation mark ",", occurring at the end, shall be deleted ;
		(ii)	in clause (vi) for the punctuation mark ",", occurring at the end, the punctuation mark ";" shall be substituted and thereafter, the word "and" shall be inserted ;
		(iii)	after the existing clause (vi), the following new clause (vii) shall be inserted, namely :- "(vii) The Inspector shall submit the inspection report as per model format in schedule -I of these rules."
